

# HIPAA Compliance Policy

## 1. Purpose

- Obligations to protect the privacy of PHI.

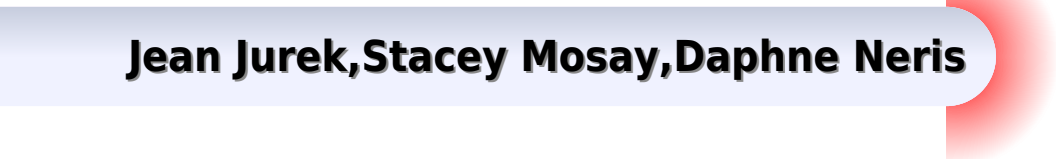
## 5. Security Measures
