Fourth, and closely related, is that changes in technology are eroding the foundational structure of the American legal system.¹³ The growing choice of technological tools with which to retrieve, sort, and manage the staggering amount of available information changes how law and information are accessed.¹⁴ These changes affect the very structure of American law, not merely how lawyers research the law.¹⁵ This places the first-year law student in a situation where how she is taught legal analysis and reasoning does not comport with what she finds when she researches the law berself.¹⁶

The challenges created by an increasingly technological world have severe ramifications for legal education and can no longer be
