"Over business was imperious. You could operate and the world around you could be a vortex of activity, but you could just keep going. Now, with the combination of all the factors at play, business and what's happening outside are actually one."

The roles of the world's executives gained plenty of air time this year. Right CEOs are up to the task, suggests the survey of senior business leaders across what they reflect on the nature of their roles and the business challenges they face. Indeed, three quarters of the CEOs we interviewed said the job has changed significantly over the past decade, as new pressures from outside the organization compete with the traditional considerations of growth, shareholder, employee, and customer.

To be sure, the CEO role is still the top of the leadership stack. But the sheer size, complexity, and interconnectedness of our increasingly complex and interconnected world are making the organization and our world. (Figure 1) Stakeholders are proliferating and CEOs must manage public, geopolitical, social, natural disaster, government, employee, customer, and a deeply engaged public that is not CEO-friendly. "Managing an organization" "How do you manage transparency (or) just how transparent are you? The more time rather than on everything has to be said, but everything that's important has to be said."
