Hubert P. Vidrine, Jr., and Tammy Joseph Vidrine, Plaintiffs, by and through their attorneys, THE CORNWELL LAW FIRM, GORDON & LILLEY, and the WASHINGTON LEGAL FOUNDATION, now come before this Court and complain of the United States Government, as follows:

I.

JURISDICTION, VENUE, AND CONDITIONS PRECEDENT

1. Plaintiffs are husband and wife. They live at 1375 Hwy 178, Opelousas, Louisiana, 70570, and thus are residents of the Western District of Louisiana.
2. The claims herein are brought against the United States pursuant to the Federal Tort Claims Act (28 U.S.C. §2671, *et seq.*) and 28 U.S.C. §§1346(b)(1), for money damages as compensation for loss of property and personal injuries that were caused by the negligent and wrongful acts and omissions of employees of the United States Government while acting within the scope of their offices and employment, under circumstances where the United States, if a private person, would be liable to the Plaintiffs in accordance with the laws of the State of Louisiana.
3. Venue is proper in that all, or a substantial part of the acts and omissions forming the basis of these claims occurred in the Western District of Louisiana, and arose from the filing and prosecution of unfounded charges of criminal conduct against Mr. Vidrine by the United States Government and its agents, maliciously and without probable cause,
