Take Acknowledgments  
Execute Jurats  
Take proofs of deeds  
Execute protests for non-payment or non-acceptance

How long is a notary appointed for? - ANSWER - 5 years

What are the prerequisites for a Notary Public of New Jersey? - ANSWER - Must be president of New Jersey and/or maintains an employment within the state  
Must be 18 years or older  
Must not have been convicted of a crime or committed an offense involving dishonesty or crime for first or second degree.

What is an Oath? - ANSWER - An oath is a spoken pledge, given by a person appearing before the Notary for truthfulness of a specific statement(s) and/or a specific performance of a specific duty or function.

What is an Affirmation - ANSWER - may be given if a persons has conscientious objections against taking an oath.

How much may you charge for an Oath or Affirmation? - ANSWER - No more than \$2.50. With no fee for swearing in a person.

Example of an Oath. - ANSWER - "Do you swear that the information presented in this document entitles "ABC", which you have signed before me, is the truth, so help you god?"

Example of an Affirmation. - ANSWER - "Do you solemnly affirm that the information presented in this document entitled "ABC", which you have signed before me, is the truth, and this you affirm under the pains and penalties of perjury?"

How can an oath and affirmation be formalized? - ANSWER - By raising the right hand and/or placing it on any holy book.
