

# HIPAA Compliance Policy

## 1. Purpose

This HIPAA Compliance Policy is designed to ensure that [Organization Name] adheres to the requirements of the Health Insurance Portability and Accountability Act (HIPAA) of 1996 and the subsequent amendments, including the Health Information Technology for Economic and Clinical Health (HITECH) Act. **Business Associate:** A person or entity, not a workforce member, who performs functions or activities on behalf of or provides certain services to a covered entity that involves the use or disclosure of PHI.

## 4. Privacy Practices

- Use and disclosure of PHI for treatment, payment, and health care operations.
- Individuals have the right to understand and control how their PHI is used.

## 5. Security Measures

To protect ePHI, [Organization Name] implements the following security measures:

- **Administrative Safeguards:** Policies and procedures designed to clearly show how the entity will comply with the act.
- **Physical Safeguards:** Mechanisms put in place to protect electronic systems, equipment, and the data they hold from threats, environmental hazards, and unauthorized intrusion.
- **Technical Safeguards:** Automated processes used to protect data and control access to data.
