"Over business was imperious. You could operate and the world around you could be a vortex of activity, but you could just keep going. Now, with the combination of all the factors at play, business and what's happening outside are actually one."

The roles of the world's executives gained global prominence after the events of 9/11. CEOs are expected to, suggest the areas of concern for many business leaders express when they reflect on the nature of their roles and the leadership challenges they face. Indeed, three quarters of the CEOs we interviewed said the job has changed significantly over the past decade as new pressures have forced the organization compete with the customer's needs, the marketplace, shareholders, employees, and customers.

"Leading in a disruptive world" is no longer a luxury, it's a necessity. "How do you manage transparency (or) just how transparent are you? The more time rather than on everything that is to be said, but everything that is important has to be said."
