My name Cassidy Peplinskie of Toronto, Ontario. I am a practicing Registered Massage Therapist and owner of a private Massage Therapy clinic within downtown Toronto. I have been certified by the College of Massage Therapists of Ontario for four years, all of which have been as an active registrant and in good standing with the College. As a Registered Massage Therapist I am a member of the Registered Health Practitioners Act (1991) and under the rule of the Massage Therapy Act (1991). I am a graduate of Humber College Institute of Technology and Advanced Learning as well as the University of Ontario Institute of Technology with a Bachelor of Allied Health Sciences (Honours). After her examination by the hospital's emergency doctor, Dr. Doe, Mrs. Doyle was diagnosed with a grade II Whiplash via physical examination and x-ray.

As a result of this diagnosis, Mrs. Doyle was referred by her physician to seek aid by way of alternative health care, as there was no fracture or disc dysfunctions present.
