We must keep record of the services provided to you and, in some cases, share that information with Doctors, Hospitals, and other related healthcare providers for the purpose of diagnosing and treating your healthcare needs. Some disclosures of your PHI may have additional restrictions as dictated by State and Federal Laws.

### **PAYMENT –**

The PHI we obtain from you as well as any financial information may be used to obtain payment from you, your insurers, or other applicable third parties. Insurance verification, treatments, and payments are permissible uses of your PHI.

### **OPERATIONS –**
