Exposition –setting, characters, background are introduced to the reader; this is the beginning of a novel or story and may be short or long, but is always flat (little action or emotion).

Conflict: - the major problem(s) in the story. These could be internal (man versus self) or external (man versus man, man versus nature, man versus supernatural, man versus technology).

Rising Action - the characters are developed, the conflicts are increased and acted out in many ways, motives are introduced, things happen; generally, it is the major part of a novel or story. Includes several events from the story.

Climax - the "high point" of a story in which the major conflicts erupt in some kind of final showdown (fight, argument, violent or physical action, very tense emotional moment...); at the end of the climax, the "winner" will be clear (there is not always a winner!).

Falling Action - what events immediately follow the climax; a kind of "clearing up."

Resolution/Denouement - where everything ends; the reader may have some sense of "closure" or may be asked to think about what might come next; in fairy tales, the "happy ending"; or you may read about the characters many years later.
