A12. It is the ratio of quick (or Liquid) assets to current Liabilities. It is expressed as

$$\text{Current Ratio} = \frac{\text{Quick Assets}}{\text{Current Liabilities}}$$

Q13. What are quick assets?

A13. Quick assets are defined as those assets which are quickly convertible into cash. While calculating quick assets we exclude the closing stock and prepaid expenses from the current assets.

$$\begin{aligned} \text{Quick Assets} &= \text{Current Assets} - \text{Stock} - \text{Advance Tax} \\ \text{Quick Assets} &= 1,34,000 - (50,000 + 4,000) = 80,000 \\ \text{Current Liabilities} &= 1,04,000 \\ \text{Quick Ratio} &= \frac{\text{Quick Assets}}{\text{Current Liabilities}} \\ &= \frac{80,000}{1,04,000} = 1:77 \end{aligned}$$
