E1.3(b) The relationship between pressure and temperature at constant volume can be derived from the perfect gas law, $pV = nRT$ [1.8]

$$\text{so } p \propto T \quad \text{and} \quad \frac{p_i}{T_i} = \frac{p_f}{T_f}$$

The final pressure, then, ought to be

$$p_f = \frac{p_i T_f}{T_i} = \frac{(125 \text{ kPa}) \times (11 + 273) \text{ K}}{(23 + 273) \text{ K}} = \boxed{120 \text{ kPa}}$$
