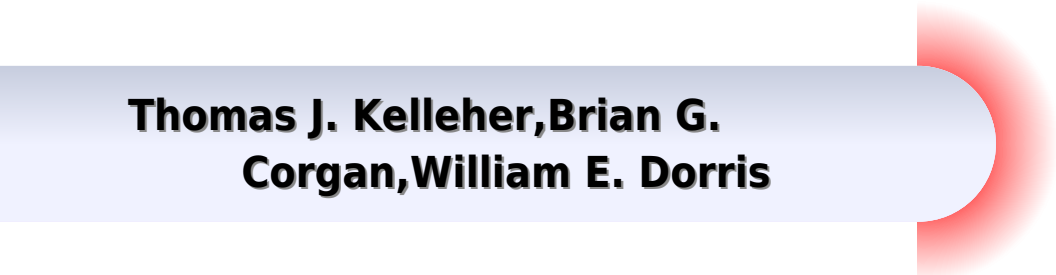


Breach of Contract Requests for Admission
