DOCUMENTATION FOR USE OF RESTRAINT

Restraint means the use of physical force or a mechanical device to restrict the free movement a portion of the student's body. Restraint may be used in an emergency situation. An emergency means a situation in which a student's behavior poses a threat of:

- Imminent, serious physical harm to the student or others; or
- Imminent, serious property destruction.

Imminent means about to occur, impending, right now.

A school employee, volunteer or independent contractor may use restraint only in an emergency with the following limitations:

- Restraint shall be limited to the use of such reasonable force as is necessary to address the emergency;
- Restraint shall be discontinued at the point at which the emergency no longer exists;
- Restraint shall be implemented in such a way as to protect the health and safety of the student and others; or
- Restraint shall not deprive the student of basic human necessities.
- Restraint shall NOT immobilize all of a student's extremities.

Training must include prevention and de-escalation techniques and provide alternatives to the use of restraint. Training must provide accepted practices and standards regarding behavior management and the use of restraint.

For these purposes, restraint does not include the use of:

- Physical contact or appropriately prescribe adaptive equipment to promote normative body positioning and/or physical functioning;
- Limited physical contact with a student to promote safety (e.g., holding a student's hand), or prevent
 a potentially harmful action (e.g., running into the street), teach a skill, or provide comfort;
- Limited physical contact or appropriately prescribed adaptive equipment to prevent a student from
 engaging in ongoing repetitive self-injurious behaviors; or
- Seat belts and other safety equipment used to secure students during transportation.
