The nominating committee shall study the needs of the church and inquire into the fitness of members to serve in the different offices.

The chairperson should call a meeting of the committee as soon as possible after its election. With earnest prayer the committee should begin preparing a list of nominees for all offices.

Having nominated persons who are faithful, loyal members of the local church, the appropriate members of the committee should inform them of their nominations and secure their consent to serve.
