THE students and faculty of the department of architecture and planning at the National Institute of Technology Calicut (NITC) are on cloud nine as their academic work has helped bring the prestigious 'UNESCO City of Literature' title to Kozhikode. A team from NITC had done a comprehensive documentation of the literary resources and assets of Kozhikode as part of the study.

The literary history of Kozhikode started in the 14th century, the study revealed. The team also worked untiringly to gather details and literary documents to prove that the city was home to many celebrated writers. The study revealed that Kozhikode has the highest concentration of libraries in India with 550, excluding personal libraries.

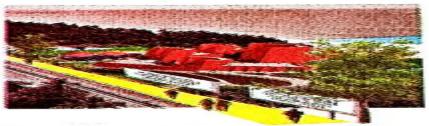
