The nominees placed on the slate shall fulfill the requirements and goals for the composition of the governing board outlined in the ANCS by-laws. It is helpful if nominees have been active in the school community and/or possess specific skills that enhances the board such as finance, human resources or management, fundraising, non-profit or other governing board experience, legal, and/or media or public relations experience. Employees of the school, other than the principals and executive director, may not serve on the board of directors; however all employees may make nominations and participate in the PTCA ratification vote.

#### Position description for all board members:

- Regularly attend all monthly board meetings and other board functions.
- Chair a board committee and/or serve as an officer of the board.
- Provide eversight of the Expositive Director.
- Provide leadership in implementing school vision and goals (including fundraising goals).
- Encourage teamwork within the group and facilitate communication among members.
- Berve as a positive force within the school.

The governing board requires representatives from both the elementary and middle school campuses. All board terms are for 3 years. Additional information about board committees and the governing board in general can be found in the ANCS bylaws located on the website.
