If the puppy is found to have any illness or defect that would prevent said puppy from being a sound pet, puppy may be personally returned immediately to BREEDER at the expense of the BUYER for a full refund. A letter from the veterinarian detailing the illness or defect is required.

If for any reason the BUYER is not satisfied with the puppy within the 72 hour time period, they may personally return it to Ethos Golden Retrievers at their own expense, provided the puppy is in the same condition as when sold.

All veterinary costs after departure from Ethos Golden Retrievers, no matter what the reason, and including the 72 hour period, are the responsibility of the BUYER.
