LAW (DEFINITION) Law can be defined as a universally accepted body of rules that aims at creating a social system that encourages people to interact voluntarily in a civilized manner; as and when there will be a violation of these regulations, the judicial system steps in to enforce order by the imposition of penalties. The study of law is a challenging aspect as it varies from state to state in India. Example:- The legal drinking age in Goa state is 18 years and 25 years in Punjab state.

LEGAL PERSPECTIVE

Legal requirements in Hotel operations covers the following areas:-

- I. Premises – It covers Electricity, Fire precautions, Food and Drugs, Food Hygiene, Food Premises, Sarai Act, Shops and establishment, Public Health & Lifts & Escalators
