OUR LEGAL DUTY:

Our office is required by law to maintain the privacy of your health information. YOUR AUTHORIZATION:

Unless you give us additional written authorization, we cannot use or disclose your health information for any reason except those described in this Notice. We may use or disclose health information to notify a family member or the person responsible for your care, of your general condition. In the event of your incapacity or emergency circumstances, we will disclose health information based on our professional judgment and disclose only health information that is directly relevant to the person's involvement in your healthcare.
