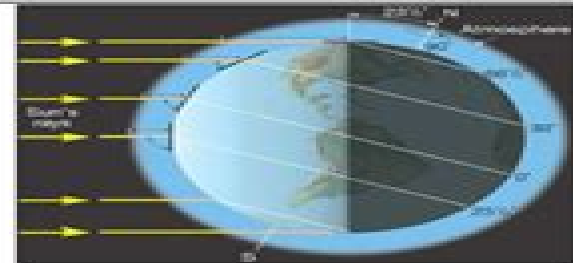

#### Earth

##### Day & Night

The Earth rotates or spins around its axis. The **axis** is an imaginary line running through the center of the earth from the North Pole to the South Pole. This rotation takes 24 hours causing the sun to rise and set (night and day). Earth's axis tilts **23.5 degrees**.



1 rotation = 24 hours or 1 day

##### Year & Seasons

It takes just over **365 days** or **one year** for the Earth to complete one revolution around the Sun. However because of its tilt, the Sun's rays hit the Northern Hemisphere longer and more directly in the summer than in the winter. When it's summer in the **Northern Hemisphere**, it is winter in the **Southern Hemisphere**.
