G.O.P. (S) - In exercise of the powers conferred by sub-section (2) of section 33 of the Finance Act, 1994 (23 of 1994) (hereinafter referred to as the Finance Act), and in exercise of the notification of the Government issued in the Ministry of Finance (Department of Revenue), No. 240005-Service Tax, dated the 29th June, 2008, published in the Gazette of India Extraordinary, vide G.O.P. (S) (2), dated the 29th June, 2008, a notification is issued as under to be done before such date as may be notified, the Central Government, as being satisfied that it is necessary in the public interest to do, hereby exempt the taxable services specified in sub-section (2) of section 65, (2)(a), (2)(b), (2)(c), (2)(d) and (2)(e) of clause (200) of section 65 of the Finance Act, provided by any person to a goods transportation by road by the said goods transportation to provide any service, referred to in sub-section (200) of section 65 of the Finance Act, to a person in relation to transport of goods by road, from the said other service tax payable Service under section 65 of the Finance Act subject to the condition that the service is used by such person (provided) provided it is not used for the same and address of the goods transportation and also the same and date of the said service, by which name called, named is to be kept.

A Study of Service Tax in India and its Analysis Dr. Makarand Raghunath Sakhalkar, 2018-03-05 Based on recommendations made by Chelliah Committee on Tax Reforms Service Tax was introduced for the first time in the year 1994. It is a Union levy with a selective approach whereby it is applicable to selected categories of services and not to all the services. The system of levy and collection of Excise Duties on goods is in existence since 1944 under Central Excise Act 1944. However, the concept of levy and collection of Service Tax on paid services was introduced in India for the first time in 1994 by the then Finance Minister Dr. Manmohan Singh. It is a tax levied on the transaction of certain specified services by the Central Government under the Finance Act 1994. It is an indirect tax which means that normally the service provider pays the tax and recovers the amount from the recipient of taxable service.
