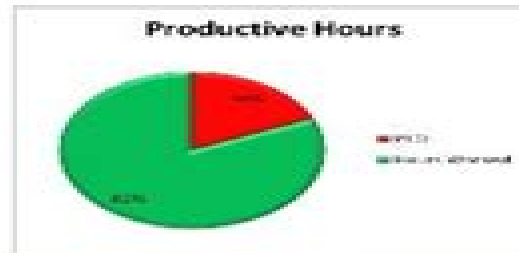
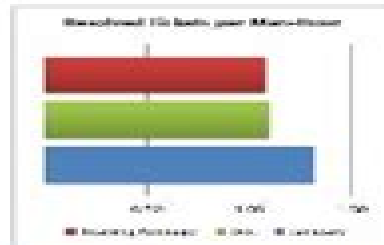

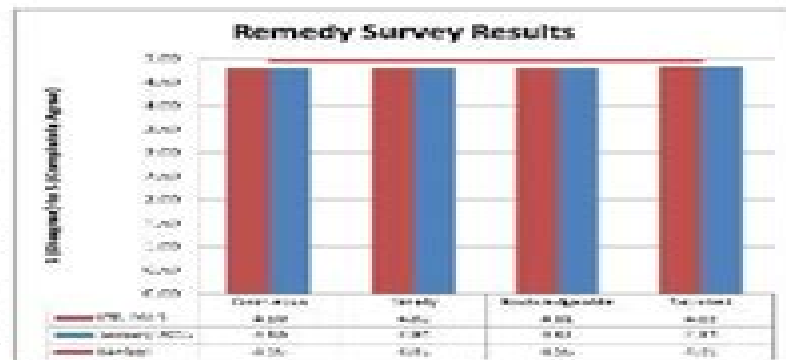
## SURVEY RESULTS
