#### Introduction

Rob could be charged with common assault.

Common law offence <u>s61 Crimes Act (NSW) 1900</u> → liable for 2 yrs imprisonment

Common assault can be divided into two categories: battery assault and psychic assault. In this instance, the assault is psychic; therefore the elements of psychic assault need to be considered.

Deal with the 2 scenarios separately:

- "Come any closer and I'll punch you"
- "If we weren't outside the club house lightful punch you on the nose"

#### Scenario 1: "Come any closer and I'll punch you"

#### Actus Reus (Psychic Assault)

D acts so as to induce fear in V that Q is about to be physically harmed by D or by another who is to act under D's orders

- Positive Act
  - Omissions can't be regarded as a positive act: Fogon [1969]
  - The could have a broad definition of what constitutes a positive act and the use of words has been held to constitute a positive act Burton v Armstrong [1969], Tout (1987) and Knight (1988)

Rob said, "Come any closer and I'll punch you". This would constitute a positive act as this threat can be said to be sufficient to ground fear of imminent violence in Jo's mind (Barton v Armstrong)

- State of mind of the victim
  - V must actually have been put in fear of imminent unlawful contact; Borton v Armstrong [1969] and MacPherson v Brown (1975)
  - V must be aware of the threat of imminent unlawful contact: Ryon v Kuhl [1979]
