for making budgetary decisions The House and Senate have also created an intricate committee system to support these processes As American society has grown and become ever more complex and as the role of the federal government in the national economy has steadily expanded Congress also has increasingly shared power over budgetary matters with the president and the executive branch It has refashioned the president s role in budgeting by requiring him to submit to Congress each year a budget for the entire federal government and giving him responsibilities for monitoring agencies implementation of spending and revenue laws Accordingly the president also exercises considerable influence over key budget decisions
