The table below was developed by John Newlands and is based on a relationship called the law of (1) properties. According to this law, the properties of the elements repeated every (2) eight elements. Thus, for example, element two and element (3) nine have similar properties. The law of octaves did not work for all the known elements and was not generally (4) accepted.

The first periodic table is mostly credited to (5) Mendeleev. In his table, the elements were arranged according to increasing (6) atomic mass. One important result of this table was that the existence and properties of undiscovered (7) elements could be predicted.

The element in the modern periodic table are arranged according to increasing (8) atomic number, as a result of the work of (9) Mosely. This arrangement is based on number of (10) protons in the nucleus of an atom of the element. The modern form of the periodic table results in the (11) periodic law which states that when elements are arranged according to increasing atomic number, there is a periodic repetition of their chemical and physical (12) properties.
