Central Government levied CGST for intra State supply and IGST for inter State supply. State Governments including Union Territories with legislatures levied SGST or Union territories without legislatures levied UTGST for intra State supply. The Goods and Services Tax GST has simplified indirect tax in India. But now almost all Indirect Taxes unified as GST across the country on Goods and Services. However Basic Customs Duty Export Duty Toll Tax Road and Passenger Tax Electricity Duty Stamp Duty and Property Tax has not been subsumed in GST.
