This research was conducted with the aim of know how rights are set and Obligation to report criminal acts according to Article 108 of the Code of Criminal Procedure and what are the legal consequences criminal if a person neglects obligations report a criminal offence under Article 108 paragraph (2) and paragraph (3) of the Code of Criminal Procedure. With Using Juridical Research Methods npormative, summed up:

1. The regulation of the right to report criminal acts according to Article 108 paragraph (1) is in the form of the right of everyone who experiences, sees, witnesses and or becomes a victim, as well as who hears for themselves, events that constitute a criminal offense to submit a report or complaint to the investigator / investigator; while the regulation of the obligation to report criminal acts in Article 108 paragraph (2) of the Criminal Procedure Code is in the form of the obligation to report when aware of an evil agreement to commit a criminal act and in Article 108 paragraph (3) of the Criminal Procedure Code in the form of the obligation to report criminal acts by public servants who in order to carry out their duties are aware of a criminal act. The implementation of this right to report sometimes faces obstacles in the form of reports / complaints back from the reported person.
2. No consequences criminal law if one ignores Obligation to report criminal acts in Article 108 paragraph (2) and paragraph (3) of the Code of Criminal Procedure cause obligations under these terms that is *lex imperfecta* (rule no perfect) only becomes a moral obligation only, not a legal obligation.
