2. Click Complete Employer Statement (E01) online.
3. Click SUPPLY EMPLOYER'S STATEMENT.
4. Enter the Online Form ID.
5. Enter the Social Security number of your employee filing for temporary disability benefits.
6. Complete all information until you receive your Confirmation Number.
