1. Services provided to the United Nations or a specified international organisation;
- 2.13 Health care services by a clinical establishment, or medical medical practitioner or practitioner;
- (2) Services provided by way of transportation of a patient to or from a hospital, where that patient is admitted to or from;
- 2.4, services provided by social health centres by way of preservation of social welfare or any other service or facilities to such persons;
- 2B, services provided by operators of the Common Bus Medical Welfare Establishment Facility or a clinical establishment by way of treatment or disposal of the medical waste or the patient's medical wastes;
3. Services by a temporary clinic or infirmary to patients of accidents or fires;
4. Services by an entity registered under section 12A,4 of the Income Tax Act, 1961 (43 of 1961) by way of charitable activities;
5. Services by a person by way of:-
"a) visiting of patients of a religious place, meant for general public, owned or managed by an entity registered as a charitable or religious trust under section 12A,4 of the Income Tax Act, 1961 (43 of 1961) referred to in the document, 42.4B, or a trust or an institution registered under sub-section (3) of clause (2C) of section 10 of the Income Tax Act or a body or an authority created under clause (2)(B)(a) of section 10 of the Income Tax Act," referred under Notification 44/2011-Service Tax, or
"b) visiting of any religious ceremony;
- 5A, Services by a specified organisation in respect of a religious pilgrimage facilitated by the Ministry of External Affairs of the Government of India, under bilateral arrangements;
6. Services provided by:-
"a) an official medical or
"b) any person other than a business entity or
