The table below was developed by John Newlands and is based on a relationship called the law of (1) properties. The first periodic table is mostly credited to (5) Mendeleev. In his table, the elements were arranged according to increasing (6) atomic mass. One important result of this table was that the existence and properties of undiscovered (7) elements could be predicted.

The element in the modern periodic table are arranged according to increasing (8) atomic number, as a result of the work of (9) Moseley.
