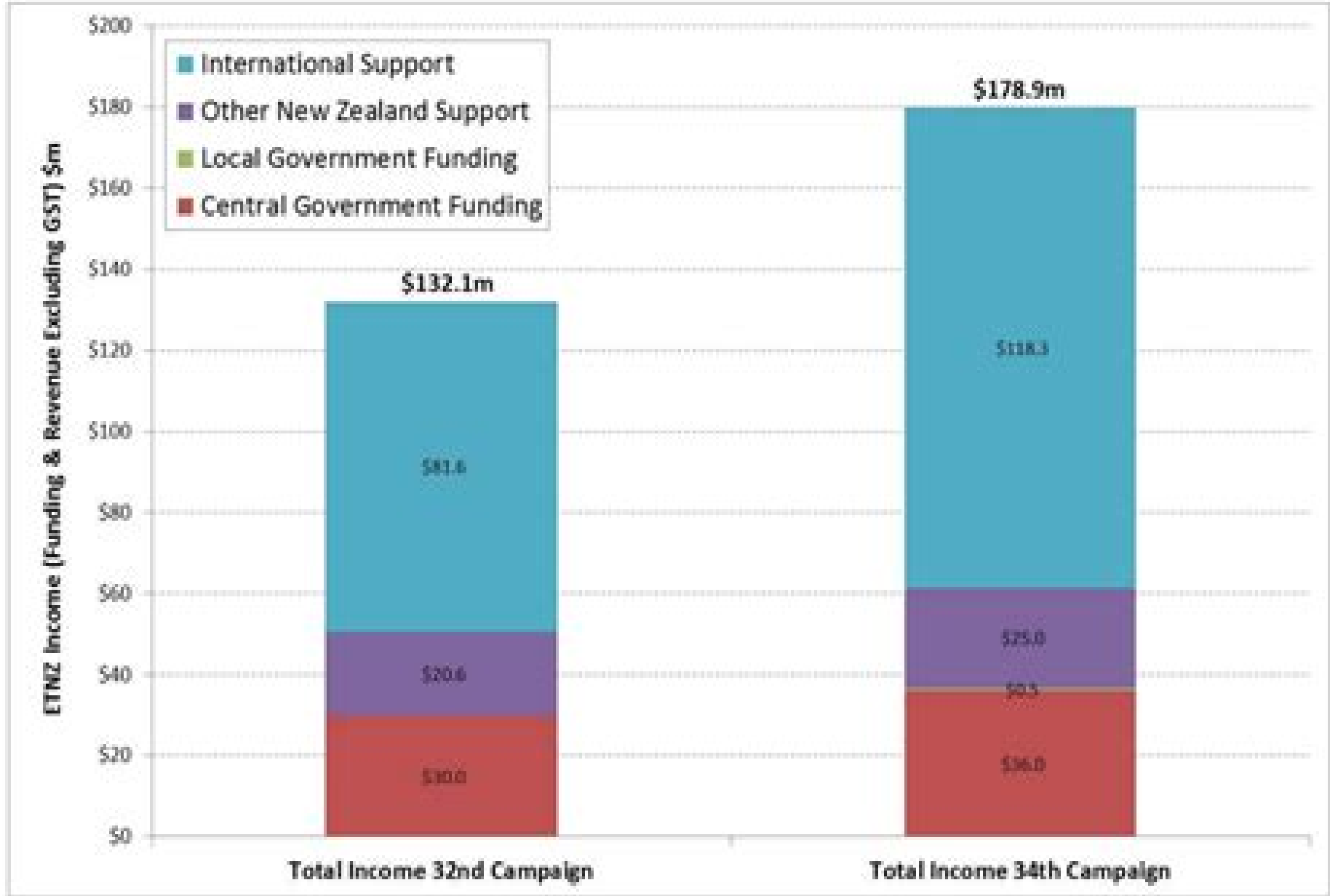


Figure 2.3: Comparison of Income by Campaign (dollars of the day)
