## Pośmiertne badanie obrazowe TK w przypadku domniemanego utonięcia – opis przypadku Postmortem CT examination in a case of alleged drowning – a case report

Autorzy przedstawiają analizę wyników pośmiertnego badania obrazowego TK w przypadku utonięcia młodej osoby w rzece. Obraz radiologiczny porównywany jest do wyników konwencjonalnej sądowolekarskiej sekcji zwłok. Analizę ilustrują rekonstrukcje 2D i przestrzenne na podstawie plików DICOM z akwizycji TK.

The authors present an analysis of postmortem CT examination in a case of drowning in fresh water of a young male. Both the results of conventional forensic autopsy and radiologic examination have been compared. The analysis is illustrated by two-dimensional and three-dimensional reconstructions based on the DICOM files obtained during postmortem CT examination.

#### WSTEP

Diagnostyka przyczyny zgonu z powodu utonięcia nie stanowi dla medyków sądowych fatwego zadania [1, 2, 3]. W konwencjonalnym (\_klasycznym") badaniu pośmiertnym wniosek taki przyjmuje się bowiem przede wszystkim poprzez wykluczenie innej przyczyny zgonu, a ani obraz makroskopowy, ani mikroskopowy płuc nie przesądza rozpoznania, chociaż w tym zakresie ciągle prowadzone są badania [4, 5, 7. 8. 9. 10]. Przedstawiane sa także rozmaite pośmiertne badania biochemiczne, których wyniki mają dowodzić zgonu wskutek utonięcia [11, 12, 13, 14, 15, 16, 17, 18, 19]. W piśmiennictwie postulowane jest poszukiwanie obecności mikroorganizmów [20, 21, 22, 23, 24, 25, 26]. Wprowadzone z poczatkiem bieżacego stulecia do praktyki sądowo-lekarskiej pośmiertne badania obrazowe TK również dają szansę wykazania zmian, które można byłoby odnieść do mechanizmu zgonu w wyniku utoniecia.
