## **Pourquoi Moi L'expérience Des Discriminations:**

**Pourquoi moi?** François Dubet, 2013. Qu'il s'agisse d'inégalités de traitement en fonction du sexe, de la race, de la sexualité, de la religion, de l'origine, des handicaps, de la santé, les discriminations sont aujourd'hui perçues et combattues comme la figure centrale des injustices. S'il est indispensable de les décrire et de les mesurer, il faut aussi que l'on sache mieux comment elles sont vécues par celles et ceux qui les subissent. Le cart est grand en effet entre les inégalités objectives et la manière dont les personnes les ressentent et surtout dont elles les tiennent pour justes ou injustes. Pourquoi moi s'efforce de rendre compte de ce vécu plus divers qu'il n'y paraît. De l'expérience totale qui fait de la discrimination le cœur de l'identité et du rapport au monde des individus, la distanciation que d'autres parviennent à installer grâce à un ensemble de stratégies et de tactiques se déploie un espace de discriminations ressenties de façon plus ou moins intense. Ces expériences sont délimitées par le jeu complexe des conditions sociales. Ainsi les plus discriminés ne sont pas nécessairement ceux qui prouvent les sentiments d'inégalité les plus aigus. La comparaison entre l'école et l'hôpital montre que les discriminations sont perçues de façon très différente dans ces institutions pour lesquelles la diversité des cultures et des personnes ne constitue pas le même enjeu. Les discriminations et les luttes qu'elles entraînent révèlent de profondes transformations de notre vie sociale et de nos subjectivités non seulement elles dévoilent des injustices intolérables mais elles montrent comment les individus essaient de se construire comme les sujets de leur liberté et de leur identité quand l'ordre social perd de son unité et de son ancienne légitimité.

*Fighting Discrimination in a Hostile Political Environment* Angéline Escafré-Dublet, Virginie Guiraudon, Julien Talpin, 2023-10-24. The book investigates the experience of ethno-racial discrimination in France and the forms that resistance takes in a colour-blind context. Among pluriethnic multi-religious post-colonial states with a long immigration history, France holds a specific place in international comparisons due to its distinct colour blindness. It does not recognize racial or ethnic groups either as legitimate social or political categories or as targets for policy. Nevertheless, the book embarks in testing existing theories on the experience of discrimination and on the diverse repertoire of collective action to fight discriminatory practices in France. It features chapters that draw on empirical qualitative research done at various levels of political action: city, regional or national, and focusing on various actors: inhabitants, activists, administrative, judicial and elected officials. The contributors argue that far from disappearing, race operates at the political level and is embedded in policy design. They highlight the centrality of institutions and policies in the production of a colour-blind racial regime. Despite the hostile character of the French political environment, the fight against discrimination takes renewed forms from infrapolitical tactics to legal battles. While the social sciences have themselves been under attack, scholarship on France demonstrates the reproduction of ethnoracial inequalities and investigates the forms that resistance to discrimination takes. *Fighting Discrimination in a Hostile Political Environment* will be a key resource for academics, researchers and advanced students of Race and Ethnic Studies, Politics and Public Policy, European Studies, Research Methods and Sociology.
