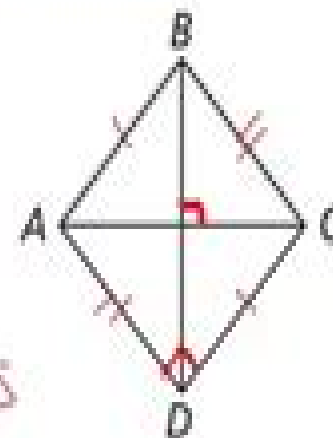

Step 3 rhomb : $\overline{AC} \perp \overline{BD}$ so diagonals are \perp , therefore $ABCD$ is a rhombus
