THE ACT

- In 1930, Sec. 76 to 123 of Indian Contract Act were taken out and a separate act was created that is the Indian Sale of Goods Act, 1930. It came into force on 1st July, 1930. With effect from 22nd September 1963, the word Indian was also removed. Now, the present Act is called 'The Sale of Goods Act, 1930'. This Act extends to whole of India except the state of Jammu & Kashmir.
