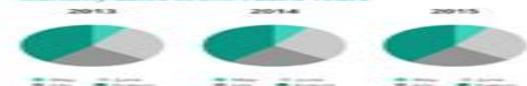

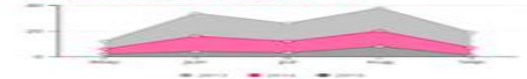
Monthly Sales in the Past 3 Years
