## Leading at the intersection: The CEO's changing role

*"Over business was imperious. You could operate and the world around you could be a matter of activity, but you could just keep going. Now, with the combination of all the factors at play, business and what's happening outside are actually one."*

The roles of the world's executives gained almost one of the most than 100 CEOs we spoke with, suggest the ways it causes the many business leaders express when they reflect on the nature of their roles and the industry challenges they face. Indeed, three quarters of the CEOs we interviewed had the job had changed significantly over the past decade, as new pressures from outside the organization compete with the traditional responsibilities to boards, shareholders, employees, and customers.
