- 1. Person who starts business of providing taxable service shall make an application for registration within 30 days from the commencement of such business.**
- 2. Notification No. 26/2005-ST dated 07.06.2005 provides that following persons shall make an application for registration under the provisions of section 69 of the Finance Act.**
  - Input service distributor**
  - Provider of taxable service whose aggregate value of taxable service in a financial year exceeds Rs. 9 Lac.**
