Societe Generale is one of the largest commercial banking groups in France. Headquartered in Paris. It was founded in May, 1864, with the name of "French General Administration of Commerce and Dual Commerce". Originally a private bank, it was nationalized in 1946 and 1979. The state controls 93.5% of the bank's capital, which is then converted into full control.

2 Playback of the case and the financial implications

Societe Generale, which has more than 200 years of outstanding achievements, is one of the largest banking groups in the world. It plays a leading role in the world's largest derivative trading market and has always been regarded as one of the banks with the best risk control in the world. However, on January 24th, 2008, it broke out the biggest fraud scandal of traders in the financial industry (Beijing UnionPay Information Consulting Center, 2008). Jerome, a 31-year-old trader. Jerome Kerviel (hereinafter referred to as JK) bought a large number of European stock index fistures without authorization, which eventually caused the Industrial Bank a loss of 4.9 billion euros (about 7.14 billion US dollars).
