EUGENICS ON THE RISE: A REPORT FROM SINGAPORE

Singapore's National Day in August 1983 was the occasion for a remarkably explicit statement by the Prime Minister, Lee Kuan Yew, of his firm convictions on intelligence, heredity, and their implications for social policy in Singapore (1). For those of us who might have thought that vulgar eugenics had fallen into irredeemable disrepute in the hands of Nazi Germany's race hygienists, the recent developments in Singapore are a startling reminder that eugenic doctrines, in their more benign forms, retain much of their plausibility for large sectors of public opinion. Indeed, the appeal seems not to be confined to politically conservative societies, but is apparent even in the People's Republic of China, where there have been recent calls for "positive eugenics . . . to accelerate the birth of individuals possessing outstanding physical and intellectual qualities" (2).

In his National Day speech that year, Premier Lee returned to a favorite theme, i.e., the importance of the quality of human material that has sustained Singapore's impressive economic growth. Coupled with his firm belief in the innate (indeed, hereditary) character of those qualities making for this success, eugenic considerations had been for quite a while an important factor in major areas of social policy in Singapore. In previous statements, public as well as private, Lee had been utterly explicit about his uncompromising elitism and his conviction that the fate of Singapore rested with an elite group of "no more than 5 per cent" who were "more than ordinarily endowed physically and mentally" (4, p. 13). This was not merely ideological cant, but was consistently carried over into social policy and most vividly typified by an elaborate tracking (streaming) system in the republic's educational set-up. For Lee, the social engineering objectives were clear (4):

We must expend our limited and slender resources [on these naturally superior individuals] in order that they will provide that yeast, that ferment, that catalyst in our society which alone will ensure that Singapore shall maintain its pre-eminent place in the societies that exist in South East Asia. . . .
