addressed to the world at large He turns the Second Amendment into a poem to illuminate its ambiguity He notices oddities and omissions The Constitution lays out rules for presidential appointment of officers for example but not removal Should the Senate approve each firing Can it withdraw its advice and consent and force a resignation And he challenges himself as seen in his surprising discussion of the Defense of Marriage Act DOMA in light of Article 4 which orders states to give full faith and credit to the acts of other states Wry original and surprising American Epic is a scholarly and literary tour de force
