## Pro Rata Debts

Pro-rata debts are debts incurred by a partnership or joint venture (JV) which are shared equally by all partners or members. These debts arise when the partnership or JV incurs a liability that is not specifically assigned to any one partner or member. For example, if a partnership incurs a debt for the purchase of raw materials, this debt is shared equally by all partners or members. Pro-rata debts are also known as "joint debts" or "common debts".

Example: A partnership of three partners, A, B, and C, incurs a debt of Rs. 1,00,000. The debt is shared equally by all three partners, i.e., Rs. 33,333 each.
