paint a more nuanced picture of Americans attitudes toward legislatures than the prevailing one derived from survey research When presented with legislative reform measures on which concrete choices were offered and decisions on them had to be made the analyses presented here reveal that counter to the conventional wisdom that people loved their representatives but hated the legislature voters usually took charitable positions toward the institution while harboring skeptical attitudes about lawmakers motives and behaviors
