

QUESTION 1**(32 MARKS : 48 MINUTES)**

Wacky Wonka (Pty) Ltd is a company manufacturing chocolates with golden wrappers. The company has been in operation for several years in Mdantsane in the Eastern Cape. The company was started by Ms. P Maduna and now has twelve shareholders, all people from the local community. The company is expanding, opening new branches all over the country. The company is a VAT registered vendor. The VAT rate is 14%.

The following extract of general ledger balances for as at 31 May 2014 for Wacky Wonka (Pty) Ltd was presented to you:

The following transactions occurred during the financial year ending 31 May 2015:

1. A new chocolate machine was ordered on 5 July 2014 for 25 000 Euro, imported from Belgium and transported by ship. The machine was delivered FOB "Free on Board" to Ostend port in Belgium on 7 July 2015 and paid for via (EFT) electronic funds transfer when the exchange rate was R11.50 to the Euro. The sea freight cost R11 250 (VAT exclusive) paid to SA Marine, via EFT on 17 July 2014 at Durban harbour. Ms. Maduna and her staff held a party at *La Vue Floating Restaurant* to celebrate the arrival of the machine, this was paid with her credit card and amounted to R3 021.00 (VAT inclusive). The machine was transported from Durban to Mdantsane with the company's own truck. The diesel cost R10 470.00 (No VAT on diesel) and arrived on site on 18 July 2014.

Compulsory testing of the new machine was completed on 25 July 2014 where 370 chocolates were made and sold for R1 850 (VAT exclusive) for cash while the costs incurred of R3 648 (VAT inclusive), were paid for in cash.

The machine was then mounted on a platform specially designed for the machine. The materials cost R650.00 (VAT exclusive), paid for in cash on 28 July 2014. The new machine was ready for use after the platform was completed on 31 July 2014.

Ms. Maduna gave all 62 employees of the company a special gift costing R171.00 (VAT inclusive) each, to thank them for their loyalty to the company.

2. Three months later on 31 October 2014 the company acquired an attachment for the chocolate machine which will increase the production capacity of the machine from 11 500 chocolates per day to 14 300 per day. The attachment which cost R57 000 (VAT exclusive) was purchased from a local agent and paid for in cash on the same day. The estimated useful life will remain unchanged.
3. Depreciation on machinery, based on the cost model, is calculated on the straight line basis with an estimated useful life of 5 years. Machinery in the ledger on 31 May 2014 has a residual value estimated at R12 000 (VAT exclusive). The new chocolate machine has an estimated residual value of R11 220 (VAT exclusive).
