supported a population of mostly self sufficient yeomen and livestock herders After the war a variety of external forces invaded the region propelling the economy through three stages of social political and economic change that permanently altered the landscape Spearheaded by New South boosters like Henry Grady these invasions were intended to create a South with a diversified economic future bright with industry and self sufficient agriculture.
