Per federal law 18 U.S.C. § 228, if child support goes unpaid for one (1) year and exceeds five thousand dollars (\$5,000) the parent could be guilty of a misdemeanor.

This carries a punishment of up to six (6) months in jail in addition to fines.

We hope to resolve this matter as soon as possible.
