Safe Forklift Operation

Forklift operators and employees working around these operations are at risk of hazards such as collisions, falls, tip-overs, and struck-by conditions.

Ways to prevent these hazards include:

Forklift Operations

- Always operate the vehicle according to the manufacturer's instructions.
- Always wear a seatbelt when the forklift has one.
- Never exceed the rated load and ensure it is stable and balanced.
- Do not raise or lower the load while traveling.
- Keep a safe distance from platform and ramp edges.
- Be aware of other vehicles in the work area.
- Have clear visibility of the work area and ensure you have enough clearance when raising, loading, and operating a forklift.
- Use proper footing and the handhold, if available, when entering the lift.
- Use horns at cross aisles and obstructed areas.
- Watch for pedestrians and observe the speed limit.
- Do not give rides or use the forks to lift people.

Safety Training

- Only trained and certified workers may operate a forklift.
- Ensure operators are trained on types of trucks in use.

Forklift Maintenance

- Remove from service any forklift found to be in unsafe operating condition.
- Keep forklifts in clean condition; free of excess oil and grease.
- Repair and maintain according to the manufacturer's recommendations.

Los operadores del montacargas y los empleados trabajando alrededor de estos están expuestos a peligros como colisiones, caídas, volcaduras y riesgo de ser impactado. Algunas maneras de prevenir estos peligros son:

Para Operar el Montacargas

- Siempre use el cinturón de seguridad cuando el montacargas tenga uno disponible.
- Nunca exceda el peso máximo de carga permitida y asegúrese de que la carga esté estable y balanceada.
- Antes de elevar la carga, ponga el montacargas en la posición neutral y aplique el freno de estacionamiento.
- Mantenga una distancia segura de las plataformas y los bordes de las rampas.
- Preste atención a otros vehículos en el área de trabajo.
- Mantenga una visibilidad clara de la zona de trabajo y asegúrese de tener suficiente espacio libre mientras eleva, carga y opera un montacargas.
- Cuando aborde el montacargas, use la barra de mano y solo pise en áreas adecuadas.
- Use bocinas en áreas obstruidas y al cruzar pasillos.
- Preste atención a los peatones y no exceda el límite de velocidad.
- No use los montacargas para transportar o elevar personas.

Adiestramiento de Seguridad

- Solamente los trabajadores capacitados y certificados deben operar un montacargas.
- Asegúrese de que los operadores estén adiestrados en los tipos de montacargas que manejan.

El Mantenimiento de los Montacargas

- Los montacargas encontrados en condiciones inseguras deberán ponerse fuera de servicio.
- Mantenga los montacargas limpios; libres de excesos de aceite y grasa.
- Haga las reparaciones y los servicios de mantenimiento según las recomendaciones del fabricante.
