### Key Requirements from Recovery Act:

- Define, identify "unserved" and "underserved" areas;
- Develop a mechanism for evaluating the appropriate levels of subsidy payments needed to provide service in such areas;
- The system must be broad and flexible enough to respond to applications from States and other government entities, nonprofits, and to support at least one grant in each of 50 states;
- Demonstrate for each grant "that the project would not have been implemented during the grant period without Federal grant assistance." (Section 6001(e)(3))
