

Proposed SEC Securities and Exchange Commission cybersecurity incident amendments

- Require companies to disclose information about a material cybersecurity incident within four business days
- Amend 10-Q and 10-K to require companies to provide updated disclosure relating to previously disclosed cybersecurity incidents and how much management knew about the incident
- Require disclosure about a company's cybersecurity policies and procedures for identifying and managing cybersecurity risks
- Require disclosure of cybersecurity governance, including the board of directors' oversight role regarding cybersecurity risks
- Require management's role, and relevant expertise, in assessing and managing cybersecurity-related risks and implementing related policies, procedures, and strategies
- Require disclosure about if any member of the company's board of directors cybersecurity expertise
- Require "cybersecurity incidents" as a reporting topic to avoid this information from being buried elsewhere in filings
